CALLED TO ORDER

Mrs. Young was present at the meeting and wanted to present her slide show to everyone of all the activities that the kids did in camp over the summer. Mrs. Young also thanked the Commissioners, the parents, and the School for all of their support and in helping make this camp possible for all the kids.

PUBLIC COMMENTS- Chairman Lewis asked for any comments from the public at this time.

One member of the audience wanted to know why the Dollar General was closed. Chairman Lewis stated that they are having an electrical issue and waiting for an approved electrician to make the repairs.

July 9, 2024 Regular meeting minutes-Motion made by Blackmon to approve the Regular meeting minutes. Second by Hayes. Voting Yes-Bussey, Kinsey, Hayes, and Blackmon. August 2, 2024 Called meeting minutes-Vice Chairman Blackmon stated that the minutes from this meeting need to have more detail added. Vice Chairman Blackmon asked that the following be added to the minutes "During the August 2, 2024 Called meeting there were options discussed to increase revenue to offset having to increase the millage and if those options came to fruition that the Commission would take the rollback next year". MANAGER'S REPORT- Chairman Lewis asked County Manager Weeks for his report. Weeks stated that he received the EMS reports for June and July. The report for June is as follows: total calls 36, 25 transports, 7 refusals, and 4 cancellations. Average response time was 7 minutes. We provided mutual aid 9 times and did not receive any mutual aid. The report for July is as follows: total calls 27, 12 transports, 11 refusals, and 4 cancellations. The average response time was 11 minutes. We provided mutual aid 1 time and received mutual aid 1 time.

FY 2024 LMIG PROJECTS-Weeks stated that the 2024 road projects have begun. They started in Winding Way and have completed 3 roads in there. They have also started on High street. They are milling High street and Weeks said that we are going to use the milling on some of the driveways in Winding Way because after the paving it has created drop offs in the driveways. One of the projects in Winding Way is to replace the guard rails on the dam and the company that is doing the project was going to throw them away. Weeks asked if we could take them up so that we can use them in other areas of the County.

RIVER BLUFF PARK- Weeks explained that he has had several things being repaired at River Bluff park. The walk way to the dock was slippery from algae and mildew and several rotten boards needed replacing. All of these issues have been taken care of. **BONA PARTES PAVING-** Weeks stated that Woffard paving is supposed to start on Thursday August 15, 2024 paving Bona Partes Retreat Rd. The engineer Tim Simpson has put some pressure on them to get started on this project.
